### General

#### **General policies**

The annual report contains a proposal for the allocation of the profit. The valuation principles and method of determing the result are same as those used in the previous year, and are as follows.

Assets and liabilities are generally valued at historical cost, production cost or at fair value at the time of acquisition. Cash and cash equivalents are at free disposal of the company and consist of directly collectable claims on credit and cash facilities, unless stated otherwise.

### Accounting policies for capital and liabilities

#### **Accruals**

On initial recognition current liabilities are recognized at fair value. After initial recognition current liabilities are recognized at the amortised cost price, being the amount received taking into account premiums or discount and minus trasaction costs. This is usually the nominal value.

## Accounting policies for the profit and loss account

#### Revenue recognition

Net turnover compromises the income from donations.

#### Other operating expenses

The other costs are determined on a historical basis and are attributed to the reporting year to which the relate.
